All nationalities except the citizens of 10 countries (Afghanistan, Bangladesh, Canada, Colombia, Iraq, Jordan, Pakistan, Somalia, United Kingdom, and United States) can apply online and get an Iran evisa on arrival.

NOTE: All visitors to Iran must hold a passport or travel document valid for 6 months at the time of departure.

Citizens of Armenia, Azerbaijan, Bolivia, China, Egypt, Georgia, Hong Kong, Lebanon, Malaysia, Oman, Syria, Turkey, Iraq and Venezuela can enter Iran without a visa.

Minimum Space: 12 m²

9 - 15 m ² has :1 table, 3 chairs, 3 spotlights, 1 electric socket, 1 information desk with chair, and 1 waste bin.

18 - 24 m ² has: 2 table, 6 chairs, 6 spotlights, 2 electric socket, 2 information desk with chair, and 1 waste bin.

≥ 25 m² has: 3 table, 9 chairs, 9 spotlights, 3 electric socket, 3 information desk with chair, and 1 waste bin.

Constructed Booth
